**ORDER:**

1. The AICTE, New Delhi and Government of A.P have accorded approval to the above college for the academic year 2019-20 vide ref (1) and (2) read above. The University has constituted a Fact Finding Committee to verify the staff and infrastructure facilities of the college to consider for grant of Temporary affiliation for the academic year 2019-20 vide Procs. (3) read above. The Fact Finding Committee has visited the college and submitted its report to the University vide (4) read above. The University has constituted a Standing Committee for Affiliation to verify the reports which were submitted by the Fact Finding Committee. The Standing Committee for Affiliation of the University has verified the reports which were submitted by the Fact Finding Committee and made recommendations for granting Temporary Affiliation for the academic year 2019-20 vide (ref.5) read above.

The Standing Committee for Affiliation has identified the following deficiencies and recommended to rectify the same and submit a compliance report, within 02 months

1. At least 50 % of the faculty appointments have to be ratified by the University
2. Faculty cadre ratio is to be maintained as per AICTE norms
3. Qualified librarian should be appointed
4. Sufficient number of titles, volumes, National & International journals should be procured and made available for library.
5. Separate room for confidential work, copier machines and internet should be made available for Examination section.
6. Biometric machines should be made available and Biometric system of attendance is to be adopted for students and staff
7. CC cameras are to be installed in all the class rooms, Exam halls, corridors, vantage points, Library & canteen
8. The college should apply for NBA, NAAC status
9. Sports facilities should be provided and Physical director should be appointed immediately.
10. Generator to be provided with suitable capacity
